## NEWSLETTER SPECIAL RUBBISH EDITION!

24 March 2001

We have finally been able to reinstate a special rubbish collection for our area. This is your opportunity to rid yourself of basically whatever you don't want. The problem had been that the Council changed their rules so that we had to take out public liability insurance which, since it costs £90 and we do not collect subscriptions, we could not afford. Thanks to *The Book of Addiscombe*, however, we are now able to afford the insurance and have it in place.

We have arranged for two special collections, the first on **Saturday 31 March between 9.00 am and 1.00 pm** and the second on Saturday 29 September. This will be what the Council calls 'static' rubbish collection at not more than three locations. Since this will be the ordinary crusher type of vehicle that collects the weekly rubbish, we have been careful in choosing these locations so as not to hinder traffic. The stopping points on Saturday 31 March will be:

- 9.00 – 10.00 am approx**      **Outside 59 Canning Road (the house with the phone box)**
- 10.00 – 11.00 am approx**      **Outside Edward Jobson Court, Canning Road**  
(many thanks to the Warden and residents)
- 11.00 am – 1.00 pm**      **In the driveway of Clyde Hall**  
(many thanks to the Trustees of Clyde Hall for giving us permission).

Please bring your rubbish to the van. If you need help carrying it, please contact us in advance. It will have a one man crew who will put the rubbish in himself. Residents are not allowed near the crushers. The whole of this exercise is designed to rid yourself of rubbish that the normal weekly collection 'refuses' to take. You may place anything in it with the following exceptions:

### **DANGER! MAJOR FINES AHEAD!**

Croydon Council with their new I-spy CCTV system are nicking residents who do a left-hand turn at the top of Canning Road into Addiscombe Road towards the Chepstow interchange during the times that this tram / bus lane is operative. This incurs an £80 penalty, or £40 if you pay quickly. We think it's iniquitous seeing as though the signage is inadequate. This affects residents and their visitors. We would like to know if you've been caught in this revenue-earning trap! We have questioned why – for the sake of an 80 yard bus lane – this is so. ## ADDISCOMBE STATION

Everyone has been asking about what is happening to this previously wonderful station.

The Council granted outline planning permission to Railtrack for demolition of the existing station building and erection of 29 houses, one three storey block of flats, one four storey block of flats and one either two or four storey block of flats. There will be 113 parking spaces and garages. The only vehicle access to this estate would be onto the Lower Addiscombe Road where the current station now stands. No prizes for guessing what that would be like in the rush hour and the resulting rat running along our roads! Behind the estate would be a green area and some additional land for Woodside infant and junior schools.

Now that the Council has granted this planning permission, Railtrack is trying to sell the site to a developer. When this happens, we'll let you know but we should have an opportunity to influence the design of the buildings. It does help that Addiscombe is a marginal political ward.

### **ADDISCOMBE STATION SITE**

It was sad to see the rapid demolition of the old Addiscombe Station which in 1864 was used as a selling point for prospective developers of the newly constructed Canning and Clyde Roads!

We have been in close negotiation with the developers, Bellway Homes, to ascertain the impact the new flats and houses will have on our area. Bellway have been keen to listen to residents' views and concerns over the construction process and we thank them for attending a meeting we held for some eight local resident associations' committee members at St Mary Magdalene Church on Wednesday 7 August. Thanks to Rev Richard Williams for allowing us to use the hall.

Bellway Homes bought the land from Railtrack with outline planning permission granted. Their proposed final plan must be agreed by the Council's Planning Committee. There will be a mixture of flats and houses, 65 units in all with 112 parking spaces. Providing the housing market doesn't falter, all homes will be for sale to private individuals. We have seen the plans and the buildings look to be of good quality. The block of flats fronting Lower Addiscombe Road is particularly attractive (see illustration below printed by kind permission of Bellway Homes).

Construction will start very soon after full planning permission is granted but it seems the Planning Committee will not meet until late September.

The timeframe for the whole development will be approximately 2 years and the block on Lower Addiscombe Road will be the first to be built. We have expressed concerns about heavy lorries using our two roads, especially since there is a nursery school in Canning Road and Clyde Road is very narrow, heavily parked and with up to five minute queues at the traffic lights. Bellway are willing to advise contractors of residents' concerns although practically they cannot control every single contractor's lorry. If there is a problem, just tell us as Bellway would like to know. Bellway have undertaken to provide parking on site for contractors to avoid the need for them to park in neighbouring residential streets.

We have also raised the question of drainage. Those who have lived in a Canning Road basement flat for a while may remember the recurrent foul water flooding which was only stopped by our persistence with Thames Water until they cleared a root ball from the sewer. We are uncertain as to whether the main sewer in Lower Addiscombe Road, into which the Canning and Clyde Road sewers run, can take the extra load. Bellway have undertaken to consult with Thames Water over this.

Croydon Council maintain that Lower Addiscombe Road can take the new traffic from the site. They are proposing to move the zebra crossing nearer to The Alma. We have voiced the opinion that people will want to cross by the shops but the Council do not currently appear willing to budge on this. If you have views on this, please let us know.

Thank you to Bellway Homes who have willingly supplied us with full plans of the site. If you would like to see them or notes of our meeting with Bellway, please let us know and we will be very happy to step you through the development. If you have any comments you wish to make on any aspect of the development, please let us know. The Council need to receive comments by the end of August.

## **LINEAR PARK**

The back part of the Addiscombe Station site will become a Croydon Council owned linear park. Croydon Councillors and Officers have expressed a wish to involve local residents in the design of the park. If anyone would like to be a part of this, please let us know. A meeting has been mooted for late September. If we hear anything, we'll let you know but - be warned - from experience it might be at relatively short notice. We very much hope that anyone interested from Canning and Clyde Roads will be given the opportunity to contribute.

## **OTHER DES RES'S**

### **Addiscombe Road and Tunstall Road**

Full planning permission has been applied for the site at 111 – 115 Addiscombe Road. This is the car showroom next to The Cricketers pub. This will involve a complete demolition, erection of eleven three-storey four-bedroomed terraced houses and three three-storey detached five-bedroomed houses with detached garages with an access road from Addiscombe Road with provision for 22 car parking spaces. The three large five-bedroomed houses will face onto the Addiscombe Road, the other development being behind.

Adjacent to this site is another different development at 127 Tunstall Road, where OCS are now. This will involve the erection of six three-bedroomed terraced houses and again vehicular access to provide nine parking spaces.

As far as we're aware, the garage development is still up for planning permission. The London Borough of Croydon has asked for certain changes to be made to the access road but permission was granted for the OCS development.

We have strongly argued that the garage site development should include a convenience shop, as we had when the site contained a filling station.

### **Lower Addiscombe Road / Leslie Park Road**

98 – 100 Lower Addiscombe Road. This is the now disused car showroom and repair shop on the corner of Leslie Park Road. The development suggested a four-storey building with two retail (Class A1) shops at street level and 23 two-bedroomed flats above. The thing that concerned us about this was the size of the retail units, which were of significant supermarket size. The latest we have learnt is that the developers are reconsidering with a mind to the effect upon local traders and that the whole of the development might just be residential. Again, we have full plans for anyone who would like to view them. We are tracking this.

And also in the vicinity, does anyone know what is going to happen to The Leslie Arms?

We were only notified about these applications by carefully scanning the Official Notices in the *Croydon Guardian* and regrettably we don't always receive this good read. The London Borough of Croydon will only notify of any such development those people who are immediately adjacent or opposite. For example, our local traders did not know of the Lower Addiscombe Road / Leslie Park Road development until we informed them. We think notification ought to be extended to any interested parties, like our association or local traders.

We have full plans for all these developments. Please contact us if you would like to see them.
