PARKING ZONES

As you probably know by now, with lots of effort from thousands of people throughout the borough, rather historically at the Council Traffic Management Cabinet Committee Meeting on Monday 2 September we managed to defeat the parking plans for outside the Central Zone. Parking restrictions in our area remain as they have been at 9.00 am to 5.00 pm, Monday to Saturday. Thank you to all who wrote to the Council or signed a petition.

We along with others are challenging the 7.00 am to midnight, Monday to Sunday restrictions in the Central Zone that were introduced at the same meeting. This could mean that our outer yet adjacent zones could take the parking overspill of those avoiding the Central Zone. It could also have implications for the popularity of Croydon as a shopping centre. If you are concerned about the impact of the proposed Central Zone restrictions, please write to the Addiscombe Councillors (addresses in our 8 August newsletter or from the Council by phone or website) and to Roger Woodward, Assistant Director, London Borough of Croydon, Parking & Technical Services, 1st Floor Davis House, Robert Street, Croydon CRO 1QQ. All of this will be challenged at the next Full Council Meeting on Monday 14 October. RUBBISH! RUBBISH! ~ SATURDAY 21 SEPTEMBER

This is to remind you that our next rolling rubbish will be on Saturday 21 September. The bin lorry will be positioned according to the following approximate times. Please note – **the times are only approximate** – if all goes quiet at one stop, we'll move on to the next, so the earlier you bring out your rubbish the better.

9.00 – 9.45 am	Opposite 59 Canning Road
9.45 – 10.30 am	Outside the Edward Jobson Court, Canning Road (near the church)
10.30 - 11.15 am	Outside 102 Clyde Road
11.15 am – 12.00 noon	Outside 39 Clyde Road (lorry may leave early if things go quiet)

There are some restrictions. Items not allowed are: **X** Fridges/freezers/white goods, **X** Building rubble, **X** Car tyres, **X** Aerosols, pressurised containers, **X** Liquids, **X** Iron bars, **X** Window frames, **X** Concrete, **X** Oil, **X** Paint

Fridges can be taken away separately for £10 by the Council. Other white goods will also be removed for a small charge, typically £10 - £15. Just phone the Council on 020 8255 2708 or 020 8255 2700 to arrange this.

Please prepare your rubbish beforehand. It is your responsibility to bring it to the lorry. If you have heavy items, let us know in advance and we will see if we can help you carry it.

The Council provide this service 'free of charge' but require the residents association to have public liability insurance. This costs just over £100 a year so contributions towards renewing the insurance would be welcome. We would prefer a cheque made payable to the Canning & Clyde Road Residents Association but, if this is not convenient, cash would be welcome.
