ROLLING RUBBISH

Just a reminder that our next rolling rubbish will take place on **Saturday 20 September**. This gives people the opportunity to dispose of those items not taken away by the weekly collection.

The lorry will arrive in Canning Road at 8.30 am. It will start at number 59, then proceed down towards Edward Jobson Court. From there it will go into Clyde Road starting at The Alma end, then work its way up towards the Addiscombe Road. Please prepare your rubbish in advance and have it ready at the front of your property for first thing on Saturday morning, close to the highway without causing obstruction to the footway. It is your responsibility to be ready and bring your rubbish to the van. If you need assistance with anything heavy, please let us know and, if feasible, we'll try to help.

There are some restrictions. Items not allowed are: **X** Fridges/freezers/white goods, **X** Building rubble, **X** Concrete, **X** Car tyres, **X** Aerosols, pressurised containers, **X** Oil, paint or similar liquids, **X** Asbestos, **X** Corrosive, flammable, explosive or toxic substances, **X** Iron bars, **X** Window frames.

General garden rubbish is allowed.

Fridges can be taken away separately for £10 by the Council. Other white goods will also be removed for a small charge. Just phone the Council on 020 8255 2708.

PLANNING APPLICATIONS

The garage next to The Cricketers on Addiscombe Road has made an application and there is another application for a pocket of land behind the garage currently occupied by OCS with access to Tunstall Road.

Addiscombe Road application is for a 3/4/5 storey building fronting Addiscombe Road comprising eight one bedroom and 25 two bedroom flats. Deadline for comments to the Council is 23 September. 127 Tunstall Road application is for a terrace of seven two storey four bedroom houses with accommodation in the roof space. Deadline for comments to the Council is 26 September.

Drawings can be inspected at One Stop, ground floor, Taberner House between 8.30 am and 4.45 pm Mondays to Fridays.

ADDISCOMBE LINEAR PARK

It was our understanding that a Friends of the Addiscombe Linear Park group would have been set up by Spring this year. The existence of this park was the justification for the demolition of Addiscombe Station to enable housing development. We have expressed interest directly to the Council on our residents' behalf and are still awaiting information. Two years after the demolition of the station the park does not exist. Shame. Why?

Rise in Council Tax from 1 April 2003 was 27%.
