

Disgraceful Rubbish

A few months back, as some of you know, one of our councillors kindly undertook an 'environmental walkabout' in our roads. This was our opportunity to inform of things that we identify as wrong that we believe that the council should put right.

It seems clear that the two major issues expressed were the state of the trees in Clyde Road, and in Canning, the poor signage that is meant to warn off motorists from making a left turn at the top of the road during certain hours, and so incur a £100 fine. This junction is number six in Croydon's top-ten traffic violation revenue earners!

We have asked our councillor what actions were recommended as a result of the visit, but regret, no reply. Checking with the forestry officer at Croydon Council re Clyde Road, he simply reports that he is aware of the situation, but has no budget this year to attend to the matter. The same response for the last three years!

Ironically, the Canning Road signage problems were slightly improved by the trees in the garden of the flats at the top of the road being hacked back so the titchy, at-the-junction warning sign is now better visible. Not quite what we had in mind!

Updates

Addiscombe Park

We finally heard that work is due to start at the end of October on the development of phase I of the new park. This will be between East India Way and Dalmally Passage. The initial work will involve the demolition of the former railway bridge and the reshaping of embankments to create a footpath link through the top of the park.

East Croydon Gateway

Croydon Council is still determined to see the Arrowcroft 12,500 seat arena on this site. The freehold landowners (Stanhope Schroder) have themselves submitted a revised planning application. A planning enguiry is booked for 24 January of next year which will hear the reasons why Croydon Council earlier refused to entertain Stanhope's application which does not include an arena. Stanhope have also acquired Lansdowne House and the HSBC surface car park in Lansdowne Road. That means that with the exception of the multistorey car park, Stanhope have now assembled the whole of the Gateway site. In anticipation Stanhope have already begun demolition of Wettern House, which will be down by Christmas. We would welcome the building of a new Warehouse Theatre, large green space, integrated office, restaurants, shops and new homes that the Stanhope scheme offers.

Planning Issues

We and our neighbours at HOME Residents Association are appalled that we are the last ones who seem to learn of proposed planning developments that could happen in our roads. For example an application to convert and extend a large house in Clyde Road to provide a high density flat development. This was learnt about by chance. The council does the statutory minimum required to just inform adjacent neighbours. If you are hear of any application, please let us know.
